

21/6087M	Demolition of part front and side wall to facilitate new 2 storey extension HOLLYOAK, FAULKNERS LANE, MOBBERLEY, CHESHIRE, WA16 7AL	No objection.
21/6092M	Proposed extensions and internal alterations to existing residential care home Leycester House Residential Care Home, EDENFIELD ROAD, MOBBERLEY, WA16 7HE	In principle the Parish Council support the improvement of the facilities in the care home but, because the plans are so detailed, there are a few queries which the Parish Council would like clarifying. Will the application overlook and affect neighbouring properties, does the applicant propose to build up a floor? Unless it impacts on neighbours the Parish Council will have no objection.
