- 6. **Report from Knutsford Community Police:** The PCSO was unable to attend the meeting but provided a report. There have been no burglaries reported. A theft of a field gate from a farm was reported on the 19<sup>th</sup> April.

## 7. Report from Cheshire East Council, Cllr. Leach:

Bulls Head – No further correspondence on this. Enforcement have been out to site. Broadoak Lane – Cllr. Leach updated the council on the judgement. Five caravans have already moved from the site. No update yet about the second planning application. Quaker's Graveyard update – Enforcement have opened an investigation. Mobberley Garages – These will be going to auction in July. Tenants will be notified and details will go in the parish council newsletter.

Cheshire East Committee System – the council have now moved to the new system.

## 8. Correspondence:

Ongoing correspondence regarding the Quaker graveyard concerns. The Knutsford Guardian have received comments given by the parish council.

Correspondence regarding objection to planning reference 21/1488M.

Correspondence from St Johns' Ambulance regarding booking space at the Rajar. No further correspondence has been received to confirm a booking. The clerk will follow this up. Correspondence regarding concerns around the grass being worn away onto the Conservation Area. The chair has spoken to the resident and confirmed this is a temporary solution for now. Cllr Swan will enquire with local contractors about a more permanent solution. A piece will be included in the newsletter.

Concerns have been raised regarding the field by the Victory Hall and the children's play equipment left lying around. The parish council will write to the Club asking them to remove the trampoline and goalposts and also to make them aware that they are not authorised to have fires on the land.

Permission requested from Mobberley Scouts to lay loose gravel on top of the grass in the damp corner of the scout hut. The parish council will not give permission for gravel but would give consideration to other solutions.

Correspondence received regarding parking at the Rajar Building. Signs will be made to make people aware that those spaces are not available. The Rajar committee will discuss this further.
